Diversity, Equity, and Inclusion (DEI) Subcommittee	Miller	President Miller introduced the DEI committee concept which was suggested during one of the sessions, addressing the Call to Action from the Chancellor's Office (changing campus climate and fighting systemic racism on our campuses). We have amazing work going on now: Equity academies; equity committee, 1619 project Guided Pathways equity team; all with the goal to improve equity for students, specifically students from historically underserved communities. The DEI committee is envisioned to work collaboratively with the above mentioned groups, and be charged to make suggestions and report to the College Council. Feedback from College Council on the idea and on the concept of reporting to CC. Drew: collecting and illustrating the various things that we are doing, recognizing a lot of components and voices; sense of inclusion in the conversation- very positive and good direction. Conversation about hiring practices- how do we incorporate it with DEI and bring this forward into our own campus work. Looking at improving our Mission Vision Values. 9. Budget Presentation	Chum	Director Chum presented the 2019-20 Fund 01 budget vs. actuals, pointing out that the College overspent by 2%. FYs 19-20 and 20-21 comparison was also presented. Our overall budget this year will be \$18, 449,161 (about \$500,000 reduction from prior year); but compared to the actual budget, it is almost \$1 million difference. It is very likely that we will be overspent this year as well. This is a structural deficit issue; the revenue that we receive is not able to cover the expenditures that we have. This issue is wide-spread among the community colleges, not an isolated occurrence for CoA.	Information
