9.	FTEF Reduction for 2020-21	Goldstein	As a result of the decline in enrollment, the District has reduced the FTEF for 2020-12 using the Budget Allocation Module (BAM). For College of Alameda, the reduction equites 36.6 FTEF with a productivity target of 17.6. Dual enrollment and high productive classes will not be effected. There is a concern that the imposed reductions did not go through a shared governance process as well as of the urgency	Information
